Late Filing of Audited Financial Statements for the Year Ended 31 December 2019

Furthermore, the Company had a change of auditing firm from KPMG to BDO Professional Services, and the new auditors required sufficient time to carry out their audit assignment, being their first audit assignment with the company.

We sincerely apologize for any inconvenience caused and are optimistic to submit the 2019 AFS not later than 29th June 2020 as graciously granted by The Exchange.
